1. SUMMER TUITION IS DUE BY THE FIRST SUMMER CLASS WITH A 7-DAY GRACE PERIOD. A \$15.00 LATE FEE WILL BE APPLIED TO ACCOUNTS ON THE 8TH DAY AFTER THE FIRST CLASS, TO TUITION BILLS THAT HAVE NOT YET BEEN PAID.

2. PAYMENTS CAN BE MAILED TO: STAGELITE ACADEMY, P.O. BOX 192, 44 NEWARK POMPTON TPKE. PEQUANNOCK, NJ 07440.

3. PLEASE ARRIVE AT THE STUDIO ABOUT 5 MINUTES PRIOR TO YOUR CHILD'S DISMISSAL. IT IS BEST TO CALL THE STUDIO IF YOU ARE NOT GOING TO BE ON TIME FOR PICK UP. IF THIS IS THE CASE, WE WILL KEEP YOUR CHILD IN THE WAITING ROOM FOR PICK UP.

4. IF A STUDENT IS ADDING OR DROPPING CLASSES, NOTICE SHOULD BE GIVEN IN WRITING, PLEASE SEE MISS COOKIE FOR INDIVIDUAL STUDENT SITUATIONS.

5. PROPER DANCE ATTIRE AND SHOES ARE TO BE WORN FOR ALL CLASSES. THE DRESS CODE FOR ALL MISS GENEVIEVE AND MR. TONY'S BALLET CLASSES ARE: ANY STYLE BLACK LEOTARD, PINK OR WHITE TIGHTS, PINK BALLET SHOES AND HAIR 'NEATLY' IN A BUN, OFF THE NAPE OF THE NECK. ALL OTHER CLASSES HAVE NO DRESS CODE BUT PROPER DANCE WEAR MUST BE WORN.

6. **"VERY IMPORTANT"**-PLEASE DO NOT DROP OFF YOUR CHILD, IN THE DRIVEWAY, ON THE SIDE OF THE BUILDING, BETWEEN THE STUDIO AND ACME FABRICS. IT IS AN ACTIVE DRIVEWAY, WITH CARS AND TRUCKS PULLING IN CONSTANTLY. PARENTS ARE ALSO NOT ALLOWED TO PARK THEIR CAR THERE EITHER, AS IT IS CLEARLY MARKED 'FIRE ZONE'. THERE IS PLENTY OF PARKING ON THE SIDE OF THE BUILDING AND ALSO IN THE BACK.

I UNDERSTAND THAT I AM NOT ALLOWED TO FORM A GROUP OF PARENTS FOR THE PURPOSE OF PRESENTING ISSUES OR COMPLAINTS, BUT THAT I SHOULD ADDRESS THE ISSUE AS IT AFFECTS MY CHILD INDIVIDUALLY AND PRIVATELY.

11. AS A PARENT, I UNDERSTAND THAT A POSITIVE ATTITUDE AND CONTINUED SUPPORT IS NECESSARY IN ORDER FOR MY CHILD TO CONTINUE THE PRIVILEGE OF PARTICIPATING IN THE STUDIO'S PROGRAM. I ALSO UNDERSTAND THAT IF I CHOOSE TO HAVE A NEGATIVE ATTITUDE OR CAUSE VOLATILE SCENES IN ANY WAY, MY CHILD AND I WILL BE ASKED TO LEAVE THE STUDIO.
